USCIS UPDATES POLICY TO AUTOMATICALLY EXTEND GREEN CARDS FOR NATURALIZATION APPLICANTS

NONIMMIGRANT WORKERS FOLLOWING TERMINATION OF EMPLOYMENT DHS AND DOL ANNOUNCE AVAILABILITY OF ADDITIONAL H-2B VISAS FOR FISCAL YEAR 2023

"Effective Dec. 12, 2022, U.S. Citizenship and Immigration Services (USCIS) is updating the USCIS Policy Manual to allow USCIS to automatically extend the validity of Permanent Resident Cards (commonly called Green Cards) for lawful permanent residents who have applied for naturalization."

As the Holiday Season Comes to a Close, H-1B Cap Season Approaches!

Are you checking at this time to see if you have any employees you are considering registering for the upcoming H-1B Visa Cap Season?

Since 2020, USCIS has implemented an electronic registration process for the H-1B Cap. The H-1B cap is a numerical limit placed on the number of foreign workers authorized to work in the United States annually under H-1B status. Under this electronic registration process, prospective petitioners (also known as registrants), who are seeking to employ H-1B workers subject to the cap, will complete a registration process that requires only basic information and pay the associated \$10 H-1B registration fee for each prospective beneficiary.

USCIS will open an initial registration period for a minimum of 14 calendar days each fiscal year. The H-1B selection process will then be run on properly submitted electronic registrations, and only those with selected registrations will be eligible to file H-1B cap-subject petitions. Selections will take place after the initial registration period closes. Last year, the initial registration period opened at 12 P.M. (EST) on March 1 and run through 12 P.M. (EST) on March 18.
